**SPRING SEMESTER SCHEDULE ADJUSTMENT POLICY**

**RETURNING STUDENTS** may visit Portal Registration to make necessary schedule adjustments until January 13, 2025, before 5:00 p.m.

**NEW AND TRANSFER STUDENTS** may only make schedule adjustments through their academic advisor via the Portal or by completing a schedule adjustment form that must include a faculty advisor's signature. Forms are available on the FSC web site (search FSC, Registrar's Office, Forms and Documents, Schedule Adjustment Form (Add/Drop). The Registrar's Office may make these schedule adjustments until January 13, 2025, at 5:00 p.m.

**ALL STUDENTS** must **contact** the Registrar's Office to withdraw from a course beginning January 13, 2025, and prior to 5:00 p.m. on March 21, 2025. **W** grades will be posted on the student's academic record. All students must obtain signatures from both the course faculty/professor and their advisor on the course withdrawal form in order to withdraw from a course. The student is responsible for submitting the form to the Registrar's Office. Verbal notification to a faculty/professor or failure to attend class does **not** constitute a withdrawal form. Students who abandon a course without filing the appropriate form may receive a failing grade. Course withdrawal forms are available in the Registrar's Office or on the FSC web site.

**Wednesday, February 5, 2025 - Final day to withdraw from an "A" course without academic penalty.**

**Friday, March 21, 2025 - Final day to withdraw from a semester course without academic penalty.**

**Friday, March 21, 2025 - Final Day to withdraw from the College without academic penalty.**

**Wednesday, April 8, 2025 - Final day to Withdraw from a "B" course without academic penalty.**
