



## GUARANTEE OF FINANCIAL SPONSORSHIP FOR INTERNATIONAL STUDENTS

**PLEASE NOTE: THIS FORM SHOULD BE COMPLETED BY THE SPONSOR, NOT THE APPLICANT**

The Immigration and Customs Enforcement (ICE) agency requires that all sources of funding be fully documented before an I-20 Form is released to any international student seeking an F-1 visa for full-time study in the US. Once completed, this document will remain on file for inspection, as required, by ICE officials. It should, therefore, be considered a legally binding contract for support. All sections must be completed. False information or failure to provide the financial support listed can have serious consequences for the student, including dismissal from Florida Southern College and possible deportation from the US.
